#### **FY2021: OPERATIONS BUDGET TO ACTUAL FOR THE TWELVE MONTHS ENDED JUNE 30, 2021**

Note: Talent Solutions includes both the Virginia Talent Accelerator Program and VJIP Program operations spending. New recurring costs for the Virginia Talent Accelerator Program were avoided earlier in the fiscal year with the anticipation of potential funding reductions. Program expenditures continued to ramp up later in the fiscal year to meet project demand and support economic recovery.

### FY2021: OPERATIONS BUDGET TO ACTUAL FOR THE TWELVE MONTHS ENDED JUNE 30, 2021

- All divisions are below budget for the fiscal year.
- Most divisions have some amount of underspending due to staff vacancies related to the state hiring freeze in the first six months of FY21.
- Underspending is primarily in the market-facing divisions (Talent Solutions, International Trade, Business Investment, and Marketing and Communications). Spending rate was lower in the first six months of the fiscal year due to the hiring freeze and other efforts to reduce expenditures during state budget uncertainty, with increased spending in the third and fourth quarters.
- Projects, Pass Thru's and Grants were under budget by \$2.2 million. This
  represents funds budgeted for the Virginia Business Ready Sites Development and
  Characterization programs that were carried forward and included in the FY22
  budget.

### FY2022: OPERATIONS BUDGET TO ACTUAL FOR THE THREE MONTHS ENDED SEPTEMBER 30, 2021

- All divisions are below budget through the first three months of the fiscal year.
- The market-facing divisions (Talent Solutions, International Trade, Business Investment, and Marketing and Communications) are under budget (16% combined). This spending rate is expected to increase as we move into the second and third quarters of FY22.
- Projects, Pass Thru's and Grants are under budget through the first three months of the fiscal year. The FY22 budget includes \$9.3 million for the Virginia Business Ready Sites Development and Characterization programs, and \$2.3 million for the Brownfields Restoration and Redevelopment Fund. Spending for these programs is expected to increase later in the fiscal year.
